

## Expansion of Hong Kong Disneyland

Following the "It's a Small World" and "Disney's Hollywood Hotel", Sun Fook Kong was awarded the contracts for the expansion of Hong Kong Disneyland. This time, Sun Fook Kong will build two new themed parks namely, "Toy Story Land" and "Mystic Point", and also the advanced infrastructure for the additional theme parks. Hong Kong's "Toy Story Land" will be the only "Toy Story Land" in the world apart from that of Disneyland Paris. "Mystic Point" will have Asian elements added which make it unique amongst Disney theme parks worldwide.



and "Mystic Point", Sun Fook Kong engaged in the construction of infrastructure and roads, which will be served as the foundation of the expansion project. The construction of the two theme spots commenced in August 2010. With the total area over 26,450 square metre, the contract sum exceeds HK\$700 million. The "Toy Story Land" project of Hong Kong Disneyland is one of the most challenging projects for Sun

Fook Kong. Mr. Hilman Yung, the Project Director of Construction Division of Sun Fook Kong Group, said, "The project commenced in August 2010 and is scheduled to open in November 2011. There is just 14 months for the construction to take place, and we have to go through all the approval processes of various

In addition, as one side of the construction site of "Toy Story Land" is adjacent to the present theme park area, there are special measures to be adopted during the construction process. Noise control has to be managed well to avoid annoying the nearby visitors. Effort is also needed to ensure confidentiality and security. A large area of the construction site is within the fireworks area, and therefore the construction site has to be cleared up and handed over for the fireworks performance every night. Revitalizing the ex-Upper Levels Police Station In March 2011, Sun Fook Kong completed the MTR West Island Line Contract – Re-provisioning of David Trench Rehabilitation Centre, which involved the revitalizing of ex-Upper Levels Police Station, which is a Grade 3 Historic Buildings. Ex-Upper Levels Police Station was built in

1935 and is situated at 1F High Street and is also known as No.8 Police Station. The architecture style was influenced by both the new classical style which was adopted by most of the important buildings in those days, and also Art Deco and Streamline Modern styles that was prevailing in that time. Ex-Upper Levels Police Station was abandoned since June 2005. In 2007, as one of the exits of the Sai Ying Pun Station of MTR West Island Line was to be built at the original position of David Trench Rehabilitation Centre, it is decided to move the rehabilitation centre to ex-Upper Levels Police Station and carry out revitalization projects.

The project commenced in July 2009 and lasted for 21 months. The contract sum reached over HK\$300 million. To revitalize the police station which has been abandoned for a long time, large amount of preliminary preparation was needed, and there were a lot of issues to be taken care of.
